These ASCLS P.A.C.E.® approved continuing education (CE) courses are available for purchase by anyone, regardless of whether they possess a national certification through NCCT or MMCI.

Instructions for completing P.A.C.E.® approved CE courses

1. Visit www.ncctinc.com/ce
 - a. Log into your existing user account if you are certified, were previously certified, or made a prior continuing education purchase through NCCT or MMCI.
 - b. Create a new user account if you are new to NCCT or MMCI.
2. Once you are logged in, from www.ncctinc.com/ce click the green “Go To Dashboard” tab
3. Click “Pay Now” from the left-hand menu to purchase the appropriate amount of CE per the table above.
4. Return to your Recertification/CE Dashboard.
5. Click “Fulfill NCCT CE Requirements” from the left-hand menu.
 - a. Scroll down to the “CE Course Search” section.
 - b. Click the box titled “Show only P.A.C.E.® - approved courses.”
 - c. Before choosing a course, check its P.A.C.E.® expiration date and do not complete any course with an expired date.
 - d. A list of NCCT’s current P.A.C.E.® approved CE courses is on the following page.
 - e. Those who are also recertifying their NCCT or MMCI national certification do not need all 14CH of CE to be P.A.C.E.® approved.
6. Click on “Read Course” to open the course material in pdf format.
7. Click on “Take CE Test” when you are ready to complete the corresponding course test for credit.
8. CE courses must be passed with a 70% or better to receive credit.

Proof of CE course completion

1. Visit your Recertification/CE Dashboard.
2. Click “CE Transcript / P.A.C.E.® Certificates” from the left-hand menu.
3. You may use either the CE transcript or the P.A.C.E.® certificates of completion for the California CPT license renewal process. Download and save the files you need.
4. Use AA #001 when completing the California Laboratory Field Services (LFS) online renewal application.
